The funds are offered by the NSW Office of State Revenue and are available under the Regional Relocation (Home Buyers Grant) Act 2011, which will operate for four yours commencing 1 July 2011.

Metropolitan means the local government areas of the Sydney metropolitan area, Blue Mountains, Hawkesbury, Gosford, Wyong, Wollondilly, Wollongong and Newcastle. The regional areas are participating local government regions that are located outside of the metropolitan area.

Abolition of the Torrens Assurance Levy in NSW

As of 1 July 2011 the Torrens Assurance Levy has been abolished. This is great news for some home buyers, as in many cases this levy added thousands of dollars to the cost of purchasing property in NSW.

The 'ad valorem' Torrens Assurance levy was applied from 1 July 2010 to all property transfers of land in NSW over \$500,000.00. Its repeal means it is no longer applied to transactions occurring after 1 July 2011 regardless of the contract value.

Keep the move smooth!

The first step in ensuring a smooth move is finding a great removalist. A good removalist will reduce stress levels for you on the day and ensure moving day runs as smoothly as possible. Ask around to get referrals, as word of mouth can help you find the best people. If you know someone who has recently moved, ask who they used and also ask for any tips they may have for getting organised, especially if you haven't moved house for a long while.

Stay organised

Planning ahead and staying organised is critical to saving time and keep costs down. Moving house can be really stressful, but if you start planning weeks before the big day, the move will be a breeze. Below are a few do's and don'ts to help make the process smoother.

Do's

- Plan ahead and book your removalists as soon as you know your moving date.
- Ask your removalists if they supply wardrobe boxes these mobile hangers will ensure clothing can be easily transported.
- If you are doing the packing, start packing and sorting through items weeks before moving day.
- Take out insurance.
- Pack items that you will need on arrival separately and transport in your car.
- If you have small children, pack together items they will need immediately and mark the box clearly.
- Keep linen for making beds separate and mark the box clearly. It will ensure beds can be made quickly.
- Keep jewellery, passports and other valuables items with you.
- Empty all petrol-powered items safely. Barbecue gas cylinders need to be purged by an authorised dealer.
- Keep cleaning equipment separate. This will allow you to clean once the removalists have gone.
- Inspect the house or unit thoroughly before you leave to ensure nothing has been left behind.

Dont's

- If someone else is packing for you, ensure articles that are not to be packed are clearly marked.
- Don't leave food in the fridge or anything in cupboards that are being moved.
- Don't hover over the removalists and tell them how to package the items. They are usually experts and understand the correct way to package your fragile items.
- Don't leave it until the last minute to book your removalist.
- Don't let anything be packed if you haven't completed the paperwork or organised insurance.
